- 1. The Wellbeing subgroup met on Monday 17th November 2014. The panel assessed four applications for Wellbeing Budget, submitted between the period of Sept 2014 and December 2014. Three out of the four applications considered were recommended for approval by the panel subject to stated conditions.

Legal Information

When councillors decide how the wellbeing fund is spent they should have due regard to the public sector equality duty that applies to all public bodies. This duty is contained in the Equality Act 2010 and came in to

7. Special Conditions:

The charge for transport is £7 per person with members paying £3 of that charge. Currently 6 people attend from St George. The application was to cover 20 weeks. The Wellbeing sub-group recommend that the cost of transport for 6 people is covered i.e. $6 \times 4 \times 20 = £480$. Woods Rd is in South Gloucestershire but is close to the north east boundary of the St George Neighbourhood Partnership, an area of the partnership where there has been little take up of Wellbeing grants, although the Mavis Friendship Club did receive another grant from the St George Neighbourhood Partnership in 2012.

7. Special Conditions:

The Wellbeing sub-group are only recommending that funding is given for the hire of the treatment room at Air Balloon Surgery. The remaining amount applied for covered administration costs, publicity and finding another venue. These appear to bring the cost per visit to £41.50 per head of which the room and the person doing the treatment costs is only £13.25. Patients cover £10 of treatment costs themselves. £41.50 per head did not seem to be a cost effective way of using funding. As a comparison Brunelcare offer home footcare visits starting with a £25 consultation and 30 minute visits for £12.50 or £25 for a 1 hour visit. The special condition recommended is that any publicity includes the St George Neighbourhood Partnership logo.

7. Special Conditions:

This application did not include quotations for the tables or the youth coaching. There are a number of questions outstanding such as the location of the club, believed to be St Aidan's Church hall but not actually specified on the application, how many coaching sessions would be funded over what time period, what number and proportion of the players come from or expected to come from the St George Neighbourhood Partnership area, the club having moved from Longwell Green. The Wellbeing sub-group recommend that further work is done to make the application more informative and that it be reviewed in the next Wellbeing round.

Summary of Wellbeing funding applications considered by the Wellbeing sub-group for the December 2014 SGNP meeting

1. Balance of funding

The total amount of Wellbeing Budget available, taking into account the amount of £2,595 transferred for use in environmental projects and the underspend of £167.03 on last year's WASP project is £3,746.92.

5 applications, meeting only the Wellbeing criteria, were received, asking for more than double the amount available in Wellbeing fund. 1 application was withdrawn as the Friends of Kingsway did not have time to answer questions raised about their application.

2. Wellbeing sub-group appraisal of applications

Four appraisal documents containing the recommendations of the Wellbeing sub-group are shown in the appendix of this document.

If the recommendations of the Wellbeing sub-group are accepted £2,656.92 will remain in the Wellbeing fund.

Overleaf is a table showing a list of groups who have applied for funding, the amounts they applied for and the amounts recommended by the Wellbeing sub-group. This may be useful as a reference note if it is decided that the recommendations of the Wellbeing sub-group should not be followed.

3. Membership of the Wellbeing sub-group

Jo Curtis has recently resigned from the Wellbeing sub-group. We would like to thank Jo for all the time and thought she has contributed since the sub-group started.

The Wellbeing sub-group currently has three vacancies. Anyone with a strong interest in St George would be very welcome to join us.

4. Availability of funding in St George

It must be noted that for the past 4 years the ward of St George West has been fortunate enough to be allocated over £35,000 of government funding to be allocated as small grants. 22 groups have been supported to run 27 projects using nearly 6,000 volunteer hours and attracting nearly £16,000 of match-funding not taking into account the value of the volunteer hours. The end of this Community First funding will mean increased pressure on the Wellbeing fund.

The Wellbeing sub-group will use their next meeting to talk about approaches to allow what funding there is to be spread as fairly as possible, meeting the highest priorities of the Neighbourhood. They will circulate their proposals to the SGNP membership. Subject to the response they will bring any changes to the process that need to be ratified to the next SGNP meeting.
