It was suggested that as this was the current policy, then it was important that it should be adhered to. It was also noted, however, that there could be an issue as to whether the current wording reflected the actual "intent" in relation to this part of the code of conduct, and that clarity would be sought by the NP Co-ordinator on this point. In the meantime, it was noted that the current wording was in place as indicated above.	Abdulrazak Dahir	Completed: The NP Code of Conduct is a governing document for all 14 NPs. The version adopted by St George NP in April stated that 'all complaints and their resolution should be reported at a subsequent NP meeting'. This clause has been removed. It was considered particularly misleading with respect to complaints against Councillors which are governed by a separate complaints procedure in which information that is made available to the public is carefully regulated. Councillors are also subject to their own Code of Conduct which is governed by law. The amended version of the NP code of Conduct is now available on the Bristol City Council website and supersedes all earlier versions and all NPs are required to abide by this.
