But with a very large number of the poorest working Glass communities in Bristol left without public transport and bus services in oidbury court parts of Fishponds, Broomhill,Stapleton, Bristlington,knowle,whitchurch estate Ashton vale Easton, Eastville,st Phillips Dings .And not able to spend bus service improvement plan money on westlink Demand responsive bus services in theses areas of bus service improvement finding on bus service s .

The transport levy has been set to low to fund the public Network. An issue now being reviewed by Banes council and south Gloucestershire council working with North Somerset council after the council elections.

The transport levy need to be addressed as the metro mayor Dan Norris has no precepting powers at the west of England mayoral combined transport Authority .

On saving the place directorate savings

In Growth and regeneration make no reference to savings that can be made To transfer of staff to the west of England mayoral combined Transport Authority. Public transport stakeholder are struggling to understand why Bristol city council has a public transport unit .

As Bristol city council is not a public transport Authority under the 2017 transport act and powers have no been transferred to provide bus services

The use of consultants to deliver public transport Network services is of concern to passengers groups and stakeholders and is not delivering for passengers. Or Taxpayers.

And has resulted in the west of England mayoral combined Authority being looked at by the Department for leveling up minister lee Rowley mp and mark HARPER mp at the Department for transport.
