Question 1

Statement 1

Friends of the Downs and Avon Gorge

FOD+AG welcomes the opportunity to update the Downs committee on our most recent activities and some of the events planned for the coming months.

FOD+AG remains committed to its core values to represent legitimate users of the Downs and to support the City Council and the Downs committee in the good governance of the Downs and Avon Gorge.

Early next month FOD+AG will hold its AGM. We have invited as our guest speakers' members of the Avon & Somerset Police to explain how the Downs are policed and to take questions from our members.

On behalf of our members, we would like to thank the committee for granting permission for FOD+AG to install a new notice board near to the Downs Cafe. Designed to enhance the visitor experience FOD+AG will be funding the project. In addition, the notice board will have two waterproof pouches to dispense information leaflets and a QR code to permit visitors to make donations towards the upkeep of the Downs.

FOD+AG received video footage of a car being driven dangerously at speed across the Downs. This was in broad daylight and without regard for the safety of other Downs users. The video clip has been forwarded to the Police for possible identification.

Winter litter forays across the Downs are now underway. At the end of October 20 volunteers enjoyed autumnal sunshine and removed significant amounts of litter and rubbish from the Zoo banks. The team will set forth again on 25th November.

The wooden bus shelter on Stoke Road has been maintained for many years by a local volunteer. In the past the Downs committee and Sneyd Park Residents Association have

assisted with the funding of this worthwhile cause. FOD+AG wish to get involved in urgent repairs to the roof of this unique structure. The roof is unusual as it is constructed from Cedar tiles. A specialist contractor has been asked to quote for the repairs. FOD+AG will look to arrange funding for the project.

Volunteers continue with a range of regular activities. We continue to assist with goat monitoring duties, raking up cut grass from the wildflower meadows, maintaining the flower borders at the Thomas Memorial and sweeping paths. FOD+AG would like to register our thanks to the Downs supervisor and his team for the cooperation willingly offered.

FOD+AG continues to support the Avon Gorge & Downs Wildlife Project as partners on the Steering Group. The range of expertise available to the group or the importance of the projects undertaken cannot be underestimated.

The Downs Advisory Panel {DAP} met earlier this month and debated a range of issues raised by Downs neighbours and users and is subject to a separate report for the Downs committee to consider. On behalf of the Panel FOD+AG would like to offer its thanks to the Avon Gorge & Downs Biodiversity Engagement and Learning Manager Anna Stevens for providing a venue for DAP meetings.

Statement 3

Downs for People

<u>Summary</u>: While we sympathise with the Committee's financial difficulties, Downs for People is unable to agree that Bristol Zoo should continue to use the North car park after the end of this year. Such use would be unlawful, and no compelling case has been made for it. If the site cannot be restored immediately to amenity use, any profits from car parking should go directly to the Downs Committee.

Background

1. At the Downs Committee meeting in September, *Downs for People (DfP)*agreed to discuss extending the zoo's tenure of its North car park beyond the end of December. This is the limit set in the court order which ended our High Court challenge to zoo parking on the Downs. Robert Bourns suggested the order could be amended if we agreed.

2. Councillor O'Rourke invited us to a meeting, saying:

"The Zoo has suggested that its current parking licence might be extended until the end of June 2025. This is so they can provide parking for the more than 400 staff and students who will continue to occupy the Clifton site until at least the end of March 2025 (the end June date is suggested to accommodate slippage in this time frame). The T&F Group would like to be able to recommend this to the DC, as it would give more time to consider properly the long-term use of the NCP, as well as delivering important income to the DC and saving the costs that the DC would otherwise incur in making the NCP secure against trespass.

It would also be a useful service to residents, as the alternative would be a big increase in onstreet parking and congestion, especially at school drop-off and collection time. "

3. *DfP* representatives met Cllr O' Rourke and Robert Bourns on 1 November. Robert Bourns said that amending the court order might be difficult. He suggested that an extension of time could instead be achieved by a '*deed under hand*'. *DfP* asked to see an example of where this had been used in a case such as ours. If a deed proved possible, we would consider if we wished to proceed with one. In the absence of any agreement, we would expect the Downs Committee to stop allowing use of the car park for non-Downs uses on 31 December.

4. Although we have not yet seen an example of a deed under hand, we decided to consider the issues now, given 31 December is fast approaching.

Consideration

5. In reaching a decision, we have been very aware of the **need to generate income for the Downs**. Cllr O'Rourke said the zoo had offered £45k to £50k for an eighteen-month extension. This is a small proportion of total expenditure on the Downs.

6. The financial benefit cannot outweigh the **fundamental unlawfulness** of what is proposed. Parking on the Downs can only be provided for those using the Downs. A deed under hand might remove the threat of action for contempt of court from failure to follow the terms of the court order. It cannot make zoo parking lawful.

7. Apart from that, we are not convinced that the reasons given justify an extension:

• use by higher education staff and students. The zoo's reported suggestion that the 180space car park is needed for higher education staff and students is hard to believe. The students come from a number of institutions and there are unlikely to be many on site at the same time. Most higher education students do not have cars. Indeed, the travel plan prepared for the zoo's last planning application for parking showed 85% of the students used 'active travel' options. The zoo gave them permits only in exceptional circumstances. Students were not allowed to use the car parks at peak times even if they paid. The zoo seems unlikely to want to pay for them to do so now. There is plenty of on-street parking on the roads nearby or on the Downs.

The zoo car park has been well-used by others since the zoo closed. It is possible that the zoo wishes to offer paid parking to all (as Michael Bothamley suggested at the last Downs Committee meeting). The zoo made substantial profits from parking when open to visitors.

• **need for more time.** Both the Downs Committee and the zoo have known since May 2021. that parking must end this year The Committee set up a Task and Finish Group on parking which produced proposals some time ago on how the car park might be

managed. Closure of the car park at the end of December (to everyone or to all but Downs users) should be straightforward. We cannot see what will be gained by delay. An extension for another eighteen months is more likely to encourage inertia. There might well be a request for a further extension at the end of that period. Parking on the grass off Ladies Mile started as a temporary measure and lasted over fifty years.

• **service to local residents.** The surrounding streets are much less congested than those around most schools in Bristol. Clifton College may have been making use of the zoo's car park for picking up and dropping off its pupils for decades. This does not justify its continuing to do so.

Conclusions

8. *Downs for People* has therefore decided we cannot agree to extending the zoo's use of the North car park beyond the end of this year. Ideally the site should be restored to amenity use. Any parking that remains must be clearly for Downs users only, with the profits going to the Committee.
