To the PROWG Committee:

Last June you, the democratically elected PROWG committee, based your decision to register Stoke Lodge as a Town or Village Green on the extensive evidence gathered over several years by the local community. We were and are incredibly proud of your courage and determination in processing the information and coming to the correct conclusion, in the face of the Inspector's refusal to even look at so much material that was relevant and meticulously verified.

Things have changed since then, but not the rightness of your decision, which is if anything even clearer now we've seen not only Cotham School's refusal to accept your democratic vote but rather to undermine it, apparently with the consent and support of unelected officials of BCC. We the community have been forced into ever more expensive legal action in defence of the registration of Stoke Lodge, which is the only way to fully protect this rare parkland - still intact with its historic Lodge and numerous protected trees - from Cotham School's money-driven ambition to develop it, and thus destroy it and its benefits for the local and wider Bristol community.

Since when has it been permissible for unelected officers of BCC to wage war on a community in this way, in support of an academy in another part of Bristol, and which is in any case financially independent of the Council? It is accepted that Cotham School, as well as having excellent onsite PE facilities, could still use Stoke Lodge TVG for PE just as it did before - before it became an academy and was coached into an entrepreneurial attitude towards what was never intended to be anything other than parkland shared for many decades with the community. The lease spells it out clearly: it was specially written to preserve the community's established use of the land for recreation and leisure. And it is open to all. Or it was - until BCC failed to act decisively and turned a blind eye to Cotham's erection of a fence that no one had agreed to and which broke all the rules. Cotham know it and BCC know it. We all know it. It is a growing disgrace to Bristol.

All the above is a disgrace to Bristol - except your principled stand for all of our democratic rights in what is supposed to be a democratically run council. It is shameful to have a council performing politically motivated contortions to try and justify unlawful policies and actions. To have BCC qua Landowner attacking the decision of its own PROWG committee goes against the spirit of the law. Please stand up against unelected, unidentifiable officers and an independent academy school using taxpayers' money to fund their bid to undermine your principled, good decision to register Stoke Lodge TVG.

BCC should be united in doing the job we elect and pay them for: looking after its people of all ages and kinds, and protecting the city's assets that contribute to communities' lives and wellbeing. Your decision to save Stoke Lodge for all Bristolians should be supported, applauded and maintained, instead of attacked.

Statement to Public Rights of Way and Greens Committee, 22 January 2024 by Helen Powell

As members of this Committee, you will be aware that Cotham School is challenging the registration of Stoke Lodge as a Village Green. That probably wasn't a surprise - but it is now being reported that the Council as Commons Registration Authority is not actively defending that registration, made following your decision in June 2023. It is even reported that the Council might, as landowner, be seeking to attack the registration.

Bristol 24/7 reported on 16 January that 'As a landowner, the council is objecting to the village green status and is seeking to switch from defendant to claimant in the case... so it will be siding with the school that the land should not be classed as a village green.' It also reports that rather than actively defending your decision, 'the council – as the Commons Registration Authority – will seek to take a neutral position and leave it for the High Court to decide whether the playing fields should be registered as a village green'.

Bristol Live reports that 'The council... will tell the judge that, as the landowner, it actually agrees with Cotham School that the land shouldn't be a village green. The council will remain on the defence list as the local authority which granted village green status in the first place, but Bristol Live understands that, in reality, the council will be firmly on Cotham School's side in the courtroom, telling the judge that it agrees the land shouldn't be a village green.'

Attempting to overturn a fully-delegated decision made by its own Committee comprising nine democratically elected councillors is not something that the Council should do lightly. I believe it would be an unprecedented step for a Council to take. You, as the members of this Committee, have fully-delegated authority under the law and under the Council's constitution to take the decision that you took. Decisions about village greens are, by law not a matter for the executive and are not supposed to be subject to political interference.

In your shoes, I would expect nothing less than a full and active defence of your decision by the Commons Registration Authority. Your decision was lawfully taken, with advice on procedure from leading Counsel. It is not appropriate for the Council to spend £100,000s of taxpayers' money attempting to undermine and reverse the registration that you decided was right to make.

It appears that the Council's constitution is being ignored. First, it is clear that any decision by an officer to challenge the registration of a village green should be referred back to this Committee. And the constitution says that the Council can only participate in legal proceedings if it is 'necessary to give effect to the decisions of the Council' or 'necessary to protect the Council's interest'. What interest would the Council be protecting by spending taxpayers' money on litigation, when the land is leased to Cotham School until 2136, and when the Council itself inserted a clause in the lease making Cotham's rights subject to ongoing community use?

Maybe we shouldn't believe all we read in the press, but if the truth is as reported then I believe the Council's approach to be unprecedented, fundamentally unconstitutional, anti-democratic and a completely unnecessary waste of taxpayer funds. It sets a terrible precedent if officers are going to start trying to overthrow fully-delegated decision-making by this committee or by planning committees.

I ask you as members of the Committee to express your views on this matter in the strongest possible terms, to ensure that the Council actively supports the entirely lawful and proper decision that you reached 7 months ago.

In the matter of the Registration of Stoke Lodge Playing Fields being registered as a Town and Village Green by the PROWG Committee under its delegated authority on June 28th 2023.

Statement: "I am frankly appalled that Bristol City Council, as the Local Planning Authority, has decided to disagree with, and challenge, the decision made by a properly constituted Committee of the Council acting in its capacity as the Commons Registration Authority, to register the land known as Stoke Lodge Playing Fields as a Town and Village Green (TVG).

I see that Bristol Council has tabled this matter on today's Agenda as a "Current TVG Application." It is no such thing. It was an Application, but is currently a TVG registration decision, that decision having been taken by a cross-party committee of elected Councillors on June 28th 2023 – the Public Rights of Way and Greens Committee. The decision taken was to register the land as a Town and Village Green. One has to ask – How dare any of the Officers of the Council challenge that decision? What right have they to make an attempt to change that decision just because they do not like the decision? At what level in the Council has this attempt been fostered? It is odious. It is anti-democratic. Surely it is even illegal?

As a member of the community neighbouring Stoke Lodge playing fields and parkland, I am very grateful for Tessa Fitzjohn's public statement that, as Chair of PROWG, she is "shocked at the council challenging a democratic decision made by the committee who voted 6-1 for Stoke Lodge to become a TVG last June".

I trust that the PROWG Committee will strongly protest about the Council's efforts to undermine its decisive vote in favour of registration, and will do everything in its power to ensure that the CRA properly defends the democratically-reached decision in favour of registration, rather than asserting that it is "neutral" which in effect favours Cotham School, despite it being an academy, independent of the local education authority.

I am absolutely appalled by this latest example of the hostility that has characterised the attitudes and actions of Bristol City Council regarding Stoke Lodge over many years of civil and legal proceedings.

Sadly, however, I can't say I'm surprised, given the history of secrecy and manipulation of facts and procedures by the Council that aided and abetted Cotham School's efforts to exert complete control over most of the site, despite the clause in the lease specifying that it was "subject to all existing rights and use of the property, including use by the community".

Bristol City Council not only refused to enforce this clause, but also enabled Cotham School to avoid the public scrutiny of a planning application to erect a fence around 22 acres of the site by suddenly declaring that the land - consistently described in documents for decades as "curtilage" of Stoke Lodge house - no longer benefited from the 1994 Grade II listing that would have been an obstacle to erecting any structures. And then Mayor Rees declared in a meeting of Full Council that "a fence is not a structure", but has persistently refused to reveal the alleged legal advice on which this bizarre claim was based - even when asked to allow our then ward councillor to view it in confidence. Peter Abrahams strongly objected, but to no avail. Another instance of how very undemocratic our council has become under the Mayoral system.

On the long and winding road towards TVG registration, the PROWG has twice voted in favour of registration, and Bristol City Council actually spent tens of thousands of pounds in 2017-18 *defending* the 2016 registration. Yet the Council now proposes to support Cotham School's action against the TVG. That is not "in the public interest" but to the detriment of the hundreds of neighbouring residents who want Stoke Lodge to be open and accessible to everyone, including schools, clubs and the community.

For decades, the public had unfettered access to Stoke Lodge 24/7, 365 days a year, for all sorts of recreation and as safe short cuts between local homes, schools and shops. By contrast, Cotham School used only a small area of the site for a few hours on termtime weekdays, but persistently - and inconsistently - locked the gates in what

appeared to be a deliberate attempt to deter people from going there. I fail to see any open and justifiable reason why Bristol City Council supports Cotham School having such unnecessary control over Stoke Lodge. Something stinks. Perhaps its rotting democracy?

Three of the five grounds for Cotham School's appeal against the 2016 registration were rejected, but the Court accepted that there were two procedural errors: the committee members had not fully analysed the evidence regarding the signs, and had not provided full and clear reasons for their decision. That's why the PROWG rejected registration in 2018.

The presence of Douglas Edwards KC at the 2023 PROWG meeting was intended to ensure that such objections would not be made again. Mr Edwards and Head of Legal Services Nancy Rollason stressed that the Inspector's report recommended rejecting the registration, but made no reference to the final note in which Mr Petchey admitted to making errors, and conceded that it was up to the PROWG committee to make its own decision.

Unlike the Inspector, who never saw much of the new evidence produced by We Love Stoke Lodge since the 2016 public inquiry (because it was never passed on to him by the Council), the PROWG Committee had access to all the relevant information. The members heard and discussed the arguments and made their own decision, each giving full and clear reasons for voting as they did: six in favour, one against, and two abstentions.

Since Stoke Lodge Village Green was registered in August 2023, the heart of our community has been restored. I walk there every day, benefiting not only from the healthy outdoor exercise and beautiful natural environment but also from the invaluable social contact of friendly conversations with other users.

In the interests of transparency, I am married to Ewen MacLeod, who has also submitted comments. We have lived at 25 South Dene since 2013, and been regular visitors to Stoke Lodge since 1997, when his mother moved to Ebenezer Lane. I was in the public gallery at the 2016 Public Inquiry, which I heard about via the Campaign for the Protection of Rural England (not any local publicity), and have attended many meetings and contributed many statements in support of Stoke Lodge remaining open and accessible to everyone. I am a supporter of We Love Stoke Lodge, which represents the interests of our community but does not have "members".

I live close to Stoke Lodge Village Green, in South Dene, with my partner and 6-year-old son, and I share Tessa Fitzjohn's shock concerning Bristol City Council "challenging a democratic decision made by the committee who voted 6-1 for Stoke Lodge to become a TVG last June".

This week, Bristol 24/7 reported that rather than actively defending the PROWG Committee's decision to register Stoke Lodge as a Village Green, "the council – as the Commons Registration Authority – will seek to take a neutral position and leave it for the High Court to decide whether the playing fields should be registered as a village green".

The Commons Registration Authority registered Stoke Lodge as a Village Green in August 2023 after a decisive vote by the wholly-delegated PROWG Committee of democratically elected councillors. Surely the CRA has a duty "in the public interest" to uphold the Committee's decision, not to assert neutrality - which in effect supports Cotham School's attempt to reverse the registration?
