APPENDIX 11: Sites excluded from byelaws.

The byelaws considered as a starting point only those sites that were recognised by the Council's Parks and Green Space Strategy (2008). In short, sites recognised by the Strategy are judged to be contributing to the city's recreational asset, contributing significantly to the landscape character of an area or contributing significantly to the visual amenity of an area. Although the Council maintains approx. 1600 areas of green space, not all in Council ownership, the Strategy considers 430 of these.

It was then determined whether these sites were held by the Council so that byelaws enabling powers may be applied to them. Byelaws for pleasure grounds public walks and open spaces are made under section 164 of the Public Health Act 1875, section 15 of the Open Spaces Act 1906 and sections 12 and 15 of the Open Spaces Act 1906. If the enabling powers cannot be applied to a site, it must be left out of the schedule.

Some sites have multiple freehold ownership and/or parts of them are held by the Council for different reasons. This can result in the enabling powers applying to part of the site and not to other parts. In these cases, the possibility of a successful prosecution is unlikely and the site has been omitted from the schedule.

Finally, some sites are recommended to Full Council in this report to be excluded from the scope of the byelaws as a result of a considered rationale put by a third party through consultation who has an interest in the site – as a result of ownership of the freehold or through a lease or licence. For consistency this rationale has been applied to others spaces and other omissions subsequently proposed.
