# 1. Welcome, apologies and introductions (Agenda item no. 1)

## 3. Public Forum (Agenda item no. 3)

# 4. GBCP Planning Day Update (Agenda item no. 4)

The Chair tabled the Notes from the Meeting held on 14<sup>th</sup> February 2017 and summarised them for everyone. The Notes are appended to this set of Minutes.

## 5. GBCP Constitutional Changes (Agenda Item No. 5)

It was agreed that Constitutional Changes could not take until the long term future of the Partnership has been decided, but in the meantime suggestions will be circulated to everyone for consideration.

# 6. Feedback on Bristol City Council Options Paper (Agenda Item No. 6)

During the debate on this the following points were highlighted:

- There were concerns about inspiring people to carry on the N P
- There is a need to engage with more people
- There is a need for a plan during the transition period
- The Partnership should be relaunched with a new name
- There is need to replace the N P with some other organisation and engage with new partners
- It provides an opportunity to encourage new organisations to join the Partnership

- There should be a new website and logo, and social media should be used as much as possible
- There is a need to identify the support that is needed from BCC staff
- Improved community engagement is required

Agreed – that the recommendations made at the Planning Meeting on 14<sup>th</sup> February 2017 be endorsed and fed into the Consultation Process.
