DECISION REQUIRED:

It is recommended that a supplementary estimate of £1m be approved for revenue expenditure to support the Clean Streets Action Plan.

1 Directorate Budget Position

This is a one off revenue investment spend to support the Clean Streets Action Plan. This is planned revenue investment resulting from additional business rates income (as noted in the Period 3 Budget monitoring report)

2 Justification

Bristol's Quality of Life Survey tells us 80% of Bristolians think street litter is a problem. In neighbourhoods which face the greatest inequality this rises to 94%. Only 34% of people are satisfied public land is kept clear of litter and refuse. This drops to 16% for neighbourhoods facing the greatest inequality. Environmental issues are often a key topic for resident groups and cause people to contact their ward councillors.

Addressing this is a key priority for the city council. The Mayor has made a pledge that Bristol will be measurably cleaner by 2020. The 'Clean Streets' plan underpins the pledge and is designed to change the behaviour of people in Bristol in order to reduce litter, dog fouling, fly tipping, graffiti and other environmental crimes by:

- Sending a clear message;
- Cleaning up the city; and
- Introducing a robust, zero tolerance approach to enforcement.

The proposed plan will below is broken down into three main areas:

- 1. Operational spend to enable the more efficient and effective clean-up of the city;
- 2. Engagement to promote the 'Clean Streets' message and enable community groups proactively clean up their communities; and
- 3. Enforcement to enable the BCC to take an 'intelligent' enforcement approach to anti-social behaviour crime.

This all aligns with the Corporate Strategy commitment:

Wellbeing Key Commitment 2 - Keep Bristol on course to be run entirely on clean energy by 2050 whilst improving our environment to ensure people enjoy cleaner air, cleaner streets and access to parks and green spaces.

The investment is subject to the resource allocation in the Bristol Waste Company and is aligned with contract.

Waste	628	Operational - New intelligent compacting bins for city centre and parks to reduce the need for emptying litter bins – which will result in more time cleansing the streets.

3 Deliverables

The deliverables arising from this investment are:

- Operational
 - The bins and refuse collection vehicle will free up resources that can be redeployed to for street cleansing;
 - The vehicles for removing graffiti will result in more graffiti being removed and from heights over 2m across the city;
 - The mobile toilet is aimed at reducing the cleansing requirements created by rough sleepers, to remove more graffiti;
- Enforcement
 - The app will create a database to provide the Enforcement Team evidence base to lead to prosecutions for graffiti and fly tips;
- Engagement
 - The funding for engagement will result in an awareness campaign about litter aimed at changing peoples behaviour, engagement with local communities and community payback which will result in more community cleansing activities throughout the city.
