SUBJECT: COVID-19: Adult Social Care Infection Control and Testing Fund

Round 3

REASON:

To authorise the allocation of the Direct Award element of the Adult Social Care Infection Control and Testing Fund Round 3.

£2,625,901 has been allocated to Bristol City Council for distribution as per guidance. The direct award element is £1,807,401

BACKGROUND:

The Adult Social Care Infection Control Fund was first introduced in May 2020, to support adult social care providers in England to reduce the rate of COVID-19 transmission. This fund has been extended until 31 March 2022 to support the care sector to put in place crucial measures over the winter period. This is a new grant, with separate conditions to previous Infection Control and Testing Funds.

The 'direct funding for providers' portion of this funding consists of 3 distinct allocations:

- infection prevention and control (IPC) funding
- testing funding
- · vaccines funding

Each local authority has received an allocation which has specifically been made available to support care providers and social care staff with the costs associated with accessing COVID-19 and flu vaccinations.

- **Direct IPC funding** allocated to care homes within the local authority's geographical area on a 'per bed' basis and CQC-regulated community care providers (domiciliary care, extra care, and supported living) within the local authority's geographical area on a 'per user' basis
- **Direct Testing funding** allocated to care homes, including residential drug and alcohol services, within the local authority's geographical area on a 'per beds' basis.

• **Direct Vaccine funding** allocated to care homes within the local authority's geographical area on a 'per bed' basis and CQC-regulated community care providers (domiciliary care, extra care, and supported living) within the local authority's geographical area on a 'per user' basis

Table above describes total allocation although payments will be made in two tranches.

FINANCIAL IMPLICATIONS

The funding will be paid in 2 tranches. The first 60% of the fund was paid to local authorities on 25th October 2021. The remaining 40% of the fund will be paid in January 2022.

DHSC expect the grant to be fully spent on infection prevention and control, vaccines and testing measures by 31 March 2022, Local authorities should prioritise passing on the direct funding for providers to adult social care providers in their geographical area. DHSC expect this to take no longer than 20 working days upon receipt of the funding in a local authority, subject to providers meeting the conditions as stated in the local authority circular. This includes social care providers with whom the local authority does not have existing contracts.

The Council has a duty to support the care market and ensure capacity and sustainability.
