#### Answer

The public engagement exercise that took place in July and August this year showed that over 80% of respondents strongly agreed or agreed with a zebra crossing in the proposed location 27m south of the St Luke's Road steps. The detailed results from the survey should now be available in full on the Ask Bristol website ([www.ask.bristol.gov.uk](http://www.ask.bristol.gov.uk)). Given this level of support from the community, Local Councillors have given their backing to this proposal and the preliminary design has now been given technical approval by officers. The next stage will be to publish a Statutory Notice to advertise our intention to install a crossing in this location. This is a legal process and gives anyone the opportunity to raise a formal objection to the proposed crossing. This takes some time to prepare. If approved, the detailed design will then be undertaken to finalise the precise details of the design before a contractor can be appointed to undertake the work (potentially Spring 2023).

Dear Sir/Madam,

I am getting in touch to express my support for plans to introduce traffic calming on Newbridge and Wick Roads.

I moved to Newbridge Road in 2014 and since then have seen a dramatic increase in traffic. I have also since then had two children and have a heightened awareness to the traffic in the area as a result. There is a particular problem with the speed of traffic, despite it being a 20mph area this is rarely adhered to. Especially on the run down to the traffic lights and by the park where to road is straight.

The lack of dropped curbs in the area makes crossing the road, for example between the park and the woods, really difficult with push chairs or kids bikes/scooters etc. The process is slow and having to do this with speeding cars whizzing pass is unsafe and stressful.

We have lived here for 7 years and have seen the dramatic impact of high speeds both on our own road and the newbridge road/wick road corridor. I walk my child to school along newbridge road and find it frightening to attempt to cross the road as people speed so dangerously along here. Statement 10

I am writing in support of the traffic calming measures on Newbridge Road and Wick Road.

My wife and I have lived on Newbridge Road for over seven years and now have a young family. However, during this time we have witnessed the steadily worsening of speeding and aggressive driving on Newbridge Road, to a point where near misses with vehicles are a regular occurrence. I have become increasingly concerned of the dangers the road is likely to pose to my family in the future should the situation be allowed to continue.

We live on the bend at the northern end of Newbridge Road and have one of the few properties with a driveway. The long sweeping bend, coupled with the excessive speeding, means we regularly run the gauntlet when having to pull out or onto our driveway. On several instances I have had close calls with speeding motorists who have had to brake sharply and skid to avoid broadsiding my vehicle.

I frequently witness vans and cars travelling in excess of 30 or even 40 mph on this road despite the numerous 20mph speed limit signs which are simply ignored. This has resulted in several accidents in the past few years including damaged to parked cars, cars mounting footpaths or veering off into adjacent woodland, and most recently, a collision with a pedestrian. Personally, whilst travelling with my wife and new born son, I narrowly avoided a head on collision with a on-coming car travelling too fast at the notorious bend at the entrance to St Annes Park.

This section of road is frequently used by school children walking or riding bikes to school at Wicklea Academy or St Annes primary, not to mention the obvious crossing point children will take between the park and St Annes Wood or Nightingale Valley. At a time when using alternative means of transport has never been so important, as well as wanting our children to grow up feeling safe to explore and cross the road between recreational / amenity areas and green spaces.

I believe significant improvements are required and are needed urgently, from the Whitby Road/St Annes Road junction in the north, down through Wick Road, in order to drastically reduce vehicle speeds, change driver behaviours and encourage drivers to use the wider, 30 mph routes available in the surrounding area instead of taking rat-runs and short cuts through our neighbourhood.

I fully support the need for traffic calming measures for Newbridge Road/ Wick Road.

#### Statement 14

#### **Statements from the Community Speed Watch group and other residents of Newbridge and Wick Roads, Brislington, in support of the CIL bid for speed calming measures along the road.**

##### 1

We are seeking CIL funding for the installation of road infrastructure to reduce speeding and improve safety on Wick & Newbridge Road in light of an increase in worrying Community Speed Watch data, traffic accidents and residents' concerns. Pedestrians must cross the road for access to the schools, doctors' surgery, local shops and green spaces, and with speeds exceeding the recommended 20 MPH limit, plus limited pedestrian crossings, safety is of high concern.

Our evidence base consists of qualitative and quantitative data, for example data from Community Speed Watch sessions; Avon & Somerset Police's data capture box and mobile Speed Enforcement Unit; multiple reports from concerned residents who have witnessed unsafe driving; have been involved in accidents themselves or have had property damaged on the road. Our statement draws on the quantitative data we have captured, and we have collated qualitative statements from residents which are supplied below.

The recently published 'WICK ROAD / NEWBRIDGE ROAD (RS15002) FEASIBILITY STUDY INTO SAFETY IMPROVEMENTS ALONG THE ROUTE' recommended a package of speed reduction measures be adopted to the estimated value of £300,000. We are seeking a fraction of that to have an impact as soon as possible.

We liaised with Avon & Somerset Police and were instrumental in having a Data Capture Box installed on Wick Road in December 2021, which reported 40% drivers over the threshold (with a total of nearly 32,000 drivers).

We have 5 years of Community Speed Watch data, in collaboration with Avon & Somerset Police, which shows the following;

- the percentage of drivers exceeding the 20mph limit across the force averages circa 8%
- the percentage of drivers exceeding the 20mph in Bristol averages circa 11%

- but the percentage of drivers exceeding the 20mph limit on Wick & Newbridge Roads averages 30-40% at every single Community Speed Watch session.

Our most recent session on the 29th of October recorded 46% of drivers exceeding the speed limit in a 1 hour. It's not just the volume of speeders that is concerning but the speeds recorded, which can be up to 60mph (even when we've been fortunate to have our local PSCO present).

The facts speak for themselves, and we are passionate about making Newbridge & Wick Roads safe for all who use it. The CIL funding would be an enormous step in the right direction.

The following statements are from residents of Newbridge Road and have been submitted unedited on their behalf by the Community Speed Watch Group. Each statement is from one individual or household.

## 2

I was recently hit by a motorist near the bend by St Annes park, it was 8am on a bright sunny morning, I had just dropped my daughter off at nursery and decided to walk through the park. I know the bend so I made sure I crossed further up giving enough line of sight for the driver. I didn't do anything different that day, I was not late for work or otherwise in a rush.

However I was hit by a car which has caused considerable damage to my lower leg, lower arm and skull which required air ambulance attendance and a 7hr operation. As I'm sure you can imagine the impact on every part of my life has been huge, as well as that of my young family, my work and the NHS. I am very lucky to have these brilliant kind people around me as well as being relatively young and physically fit.

Without the support of those people and the people on the scene, my quality of life would be significantly detrimentally affected, not just physically (although that is likely to be ongoing issue for me) but financially and for my families emotional wellbeing.

My point is I am young, fit and aware of the world around me. The driver was not over the alcohol limit. There are others in a much less fortunate situation either age/health or support from work/family, there are children heading into the entrance to the park, people on scooters.

This is not the first incident, and speed will always be the most important factor, physical traffic restrictions are needed if you want to cars to slow down.

The consistent speeding on Newbridge Road and Wick Road continues to impact the quality of life of it's residents. Whilst the majority of roads suffer from the blight of drivers ignoring the rules, our 2 roads are consistently the worst in Bristol.

This is evidenced by:

1. Details published in local press showing Newbridge Road in the top six for active speed camera offences for the region, the five roads above Newbridge all had fixed speed cameras, including the M32, whereas Newbridge Road's offences were recorded from the occasional visits by a mobile Police speed camera van.
2. Avon and Somerset Roads Policing described Newbridge Road as '**...our busiest mobile Bristol enforcement site!...despite pristine signage, many cyclists & lots of crossing school children...**' On the day of this quote, they recorded an incredible 132 offences in just 2 hours.
3. There is also a dedicated local Community Speedwatch Group. Their findings not only show on Newbridge Road and Wick Road the highest proportion of vehicles exceeding the speed limit across the Avon & Somerset Police area, it's almost double the next highest number recorded by other Speedwatch Groups.

The impact of this includes:

- I. My own vehicle had been hit 6 times on Newbridge Road before being written off by another speeding motorist this year, along with his own car and another neighbour's vehicle. He was overtaking a van which was observing the 20 mph limit and lost control.
- II. Tailgating and overtaking are a common occurrence whilst I'm travelling within the 20 mph limit.
- III. Pedestrians have been hit numerous times, including one recently who needed air lifting to hospital and suffered life changing injuries.
- IV. Cyclists suffer the same, with one being hit and thrown into a parked car by another car travelling at high speed.
- V. The St Annes Wood park railings are rarely seen intact, they are hit frequently with vehicles leaving the road at high speed. The cost of the railings and street furniture repairs in Newbridge Road over recent months probably exceed the cost of the requested speed calming measures and the cost of the necessary frequent attendance by the Police speed camera van certainly will.
- VI. The cost of Police attendance at the frequent accidents on the road only adds to this and the cost of the aforementioned serious injury alone would, I guess, have cost more than £100,000 for the police, ambulance, helicopter and hospital care.

Overall, these 2 roads are evidenced as the worst in Bristol for drivers exceeding the speed limit and the impact on the lives of its residents remains horrendous.

We have lived on Newbridge Road since 1990 and have witnessed accidents on a regular basis which have included injury to neighbours, damage to cars & to property.

With two schools and a nursery in close proximity, there is a large footfall of parents and young children each morning and afternoon. We have also seen a growth in community use of St Annes Park, which although very welcome, has also added to the numbers of pedestrians on Newbridge Road.

We believe that the present layout of the road encourages many drivers to accelerate after ascending the hill in the west, or turning the corner by St Annes Park in the east. This long stretch of road regularly sees cars exceed the speed limit of 20 mph, a fact borne out by the presence of a police speed camera van on a weekly basis.

We feel that present signage advising of the 20 mph speed limit is inadequate, with one sign on the St Annes Woods side often obscured by trees during the summer. We believe that the only effective action would be the installation of traffic calming measures that force drivers to stop at specific point(s) along Newbridge Road.

### Statement 19

Statement in support of funding for Newbridge Road / Wick Road speeding measures

Newbridge Rd is minor road lined with residential houses, several primary schools, parks and many cyclists - children and adults.

It is now considered to be the busiest enforcement site in Avon and Somerset with 132 speeding offences in 2 hours, despite the highly visibly speed enforcement van.

Personal experience of Newbridge Road:

- My 10 and 12 year olds cycle on Newbridge Rd everyday as part of their route to school - due to several near misses with speeding traffic I will only now let them cycle on the pavement on this road as there is no lane or path for cyclists.
- When I drive 20 mph on Wick Rd and Newbridge Rd I have been overtaken by people getting frustrated with me sticking to the speed limit, I have been beeped and sworn at for going 20mph. This has happened so many times I have lost count. During the night speeding drivers continue to beep at cars sticking to the limit.
- I feel unsafe walking along the pavement on Newbridge Road with my children - especially on the corner near the entrance to Nightingale Valley due to the speed at which vehicles take the corner which has several times resulted in crashes into the wood boundary fence.

As the road stands today is only a matter of time before there is a fatality on this road and to take no action to stop speeding vehicles would be a serious error or judgement and one I would not want on my conscience if I had the power to make this change.

In light of the above I consider that simply just telling people to slow down with signs and cameras is not enough as too many motorists show a lack of care and disregard for personal and public safety.

Therefore, the only solutions that will have an impact on slowing down traffic to prevent injury and death would be physical solutions such as raised junctions and speed tables and I support funds going towards this.

Everyday I experience people speeding down the road using the route as a cut through to avoid traffic on the A4. I have two children under 3 years of age and I feel anxious every time I take them out the front of our house due to the speed of the motor vehicles. The speed limit, as you know, on this road is 20mph however, people rarely stick to the speed limit. We have a vehicle that we have to park on Wick Road due to no off road parking. To enable wheelchair users and individuals with buggies to use the footpath we park next to the footpath. This is in contrast to several other users who park on the footpath. As a result in the five years that we have lived on Wick Road we have had to replace our wing mirror five times and our car has been hit by another vehicle while stationary. This is of great expense to ourselves and we are currently undergoing legal action regarding the road traffic accident. The other reason for parking our vehicle on the road and not on the footpath is that it forces the traffic to slow down because two vehicles are unable to 'squeeze' by each other at the same time. As such, we have created our own speed calming to some extent. I have had letters of abusive posted on my car windows stating that this is a busy road and I should not be parked in this manner. A manner that is perfectly legal. It is known to the council that Wick Rd. is dangerous and speed calming is required based on various reports. If traffic calming were put in place it may also stop those individuals who are aiming to cut through to rethink this reroute.

Given that there are three schools on the Wick Rd/Newbridge Rd route it seems highly necessary, and long overdue, that speed calming be introduced!

Wick Rd & Newbridge Rd are a crucial spinal transport route for local residents and commuters and a wider part of our city. But it is currently skewed towards motorists using it as a rat run. It's current layout means motorists are encouraged to speed, and further more adopt aggressive behaviours towards other road users such as pedestrians and cyclists. There is a vast amount of data showing how this is one of the worst roads in Bristol for car accidents, speeding and aggressive motorist behaviour including road rage accidents. The reasons this is necessary are the following:

1. A crossing is necessary because the pavement on the park side actually stops at the railway bridge, which means it is unavoidable to cross the road.
2. There are many people needing to cross the road here, as they come from Newbridge road or from across the park in order to reach the amenities on the other side.
3. The people needing to cross the road are young and/or vulnerable, including:
  - a) infant children (aged 2-5) attending the Kindergarten Forest School in Nightingale valley woods,
  - b) primary school children (aged 7-11) attending Wicklea Academy.
