# Introduction

This survey booklet is accompanied by a separate information guide, which provides information about the council's budget and our proposals.

In this survey we ask you for your views on alternative options for the level of Council Tax and Social Care Precept. We are also seeking your views on our proposals for ways we can save money and generate more income to bridge the funding gap over the five years to 2027/28 and set a balanced and legal budget for 2023/24.

Some of the savings proposals would be implemented over more than one year. We have included a comments section where you can explain your reasons and give us your suggestions for other ways we might save money or increase income to balance the budget.

## Council Tax and Social Care Precept

**Question 1** asks for your views on alternative options for the level of Council Tax (no increase, or an increase of 1%, 2% or 3%) next year to help cover some of the financial pressures the council faces.

For each option we state how much money would be raised in one year (to the nearest £0.5 million) and how much this would add each week to the Council Tax bill for a Band B property (Band B is the most common banding of property across Bristol). For other Council Tax bands, you can use the table below to see how much each option would add to your Council Tax bill for your property band.

**Question 2** asks you what level of Social Care Precept you think we should apply (no increase, 1%, 2% or 3%) in addition to the increase in Council Tax in question 1 to support the delivery of social care services.

Social Care Precept is an additional charge which councils are permitted to add in some years on top of the Council Tax increase to help pay for social care.

For the first two options, we have provided the amount of additional savings or income we would need to generate compared with Option CT2: an increase of 2% to Council Tax.

(A 2%<sup>1</sup> increase in Council Tax is the assumption used in our current budget forecast.)

#### Option CT0: No increase to Council Tax

This option would increase our funding gap by £5.0 million each year on top of funding scenarios/gap already identified.

#### Option CT1: An increase of 1% to Council Tax

This option would raise £2.5 million to support the delivery of services. This option would increase our funding gap by £2.5 million each year on top of funding scenarios/gap already identified. This option would add around 28 pence per week to the Council Tax bill for Band B properties.

#### Option CT2: An increase of 2%<sup>1</sup> to Council Tax

This option would raise £5.0 million to support the delivery of services. This would make no change to the current funding gap assumptions. This option would add around 57 pence per week to the Council Tax bill for Band B properties.

#### Option CT3: An increase of 3%<sup>2</sup> to Council Tax

This option would raise £7.5 million to support the delivery of services. This is £2.5 million more than we assumed in our forecast so it could reduce the amount of savings proposals needed in 2023/24 by £2.5 million. This option would add around 85 pence per week to the Council Tax bill for Band B properties.

This option would raise no extra income to support the delivery of social care in 2023/24.

This option would raise £2.5 million to support the delivery of social care. This option would add around 28 pence per week to the Council Tax bill for Band B properties.

#### An additional 2% Social Care Precept

This would be an extra 2% increase to Council Tax in addition to the increase in Council Tax you chose in Question 1.

This option would raise £5.0 million to support the delivery of social care. This option would add around 57 pence per week to the Council Tax bill for Band B properties.

#### An additional 3% Social Care Precept

This would be an extra 3% increase to Council Tax in addition to the increase in Council Tax you chose in Question 1.

This option would raise £7.5 million to support the delivery of social care. This option would add around 85 pence per week to the Council Tax bill for Band B properties.

Supporting Fostering Services to recruit and retain foster carers, with innovative approaches and strategies to encourage and support people with the right skills and experience to come forward and offer some of our most vulnerable children an opportunity to experience a stable family life. This will reduce duplication of application for the customer, improve response time and achieve cost reductions. This area of activity has the potential to significantly increase should the adult social care charging reforms be rolled out as planned and as a result achieve greater future year efficiencies.
