## 1. Background:

a. 6 Area Committees were approved at the Full Council meeting on 20<sup>th</sup> March 2018 to hold delegated decisionmaking powers over non-earmarked Section 106 and local Community Infrastructure Levy (CIL) funds.

b. Area Committee 4 consists of the councillors representing the wards of Ashley, Central, Lawrence Hill, Easton, St George West, St George Central and St George Troopers Hill.

c. Each Area Committee will meet formally once a year (with the option of a second, additional meeting if required) to make decisions on the awarding of local CIL and S106. 15% of CIL generated within each Area Committee area is available for spend. Those parts of an Area Committee which have a formally adopted Neighbourhood Development Plan receive 25% of the CIL generated within the defined border of their Plan to support their identified infrastructure priorities.

## 6. Community Infrastructure Levy (CIL) and Section 106 Monies available to Area Committee 4 at 31st October 2022

## a. CIL available:

At the end of October 2022 there was an overall sum of **£984,881.18** available to Area Committee 4, which breaks down as follows:

## For General AC4 expenditure: £327,518.86

For Old Market Neighbourhood Plan expenditure: **£657,362.32**.

If the Committee approves all the requests for CIL funding at Item 6 the following CIL funds will remain:

- For General AC4 expenditure: £96,341.14
- For Old Market Neighbourhood Development Plan expenditure: £357,362.32.

### b. Pre-commitment of future CIL receipts:

i. Area Committees may wish to approve funding for a Stage 2 Proposal by pre-committing 'still to be received' CIL funds to its delivery. This would mean that any project which was approved in this way would be the priority to receive all incoming CIL until such date as its approved funding allocation was accumulated in CIL receipts by the Planning Obligations Manager.

ii. Because of this these projects would not be able to receive a Funding Agreement, start any work which relies on CIL funding or receive any access to funding until the full CIL monies is accrued.

iii. This means that the Area Committee will need to be very clear which project(s) are its priorities for immediate action to support with currently-available CIL and which it is prepared to subject to delayed start by approving funding through pre-commitment.

iv. The rate at which CIL is paid to the Council is unpredictable and therefore the delayed start for these projects is similarly impossible to predict.

v. Pre-commitment of future CIL income will impact on the Area Committees ability to consider new

proposals in future years

## c. Section 106 available:

- i. At the end of October 2022 there was a total of **£242,279.22** uncommitted Section 106 agreement monies available for AC4. See Appendix 2
- ii. Of this sum £168,274.42 is for Transport-focused work; £74,004.80 is for Tree Planting.
- iii. All S106 agreements are legally bound to be spent according to the Purpose of the Contribution so can only be approved for projects which met these conditions.
- iv. None of the available S106 have any immediate or urgent time limit on their spend.

## **Proposal 1: AC4PO12 Improvements to Broad Plain / Temple Way Underpass**

Please describe the project you want to deliver (200 words maximum) (attach any plans, drawings etc as an appendix): Concerns have been raised around the quality of the local environment, accessibility, the quality of provision for pedestrians and cyclists and personal safety regarding the Temple Way underpass.

This project will seek to obtain more information on what these concerns are and address these as appropriate.

The project is in line with Broad Plain Public Realm Strategy 2020 and Old Market Neighbourhood Development Plan and will link with planned S278 work for 1 Temple Way. This is a key pedestrian and cycle route connecting Temple Quay, Old Market and Broad Plain to the rest of the city. The absence of a pedestrian crossing across Temple Way at this key location makes this route crucial to access to this part of the city.

The Business Improvement District (BID) will fund an engagement process and development of the Design Brief, conducted by local business, Streets Reimagined.

This process will determine what specific measures the community would like to see to address the concerns in this area, which will then be passed over to the relevant BCC teams to consider on technical grounds and deliver as appropriate with the CIL funding allocated.

The project might include all of, a combination of or similar treatment to achieve the same outcome as:

- Improved lighting to the subway
- Improved cleanliness through artwork and surface changes
- Opening up the western entrance to make it more pedestrian friendly

Other options will be considered as a result of further local consultation but will be limited by the budget allocated.

TALO is a community organisation based in the heart of St. Pauls whose purpose is to improve economic status and personal wealth within the community, improve social engagement, improve relationships within the family setting and the wider society. Since being established TALO has built its reputation within the community in terms of high-quality service provision – addressing the social, cultural, welfare and economic needs of the Communities within Central and East Bristol. TALO also works

- To deliver culturally competent services
- To advocate for clients to enable their voices to be heard
- To bring families closer together through a range of play activities

#### Section 2c. Your Project:

**i.** Please describe the project you want to deliver (200 words maximum) (attach any plans, drawings etc as an appendix): The vision is to transform the focal space of St Paul's gardens (currently unused and aesthetically unattractive to the eye) to an oasis that includes an adventure park, plenty of greenery, a sensory garden, contained football area and respite areas.

This space that's located just outside Halston drive community room, was renovated more than 10 years ago with a large sculpture in the middle that has wording reflecting a consultation with the community. The space, locally named as 'rock park',

has a couple of worn out benches and a terrain that's dusty and uneven. Currently, the only use of the space is made by young boys playing football and coming home with clothes and shoes worn out due to the surface. The space is also occasionally used to walk dogs.

TALO works extensively in the area, through both its advocacy work and play work and is familiar with the concerns of the community when it comes to areas of improvements in the area. This space along the small park located next to it, has reached top in the list of priorities needed in the area according to residents.

As all our projects, community involvement is key to enable a successful outcomes for the all stakeholders involved but especially the service users, hence the community will be involved from the beginning to shape this project so that it's purposeful for many years.

There are other nearby parks at a walking distance such as St Agnes and St Paul's park which have received renovations in the last few years, however, families with children have said that these parks can only be accessed with supervision of an adult due to fear of crime, grooming, drugs near the parks. However, this can pose a problem when children want to play outdoors due to their housing situation generally limiting both indoor and outdoor space. This is why the space that would be the oasis and the small park next to it are usually highly frequented; it's right in the middle of the flats and in full view which allows parents and carers to keep an eye on their children when they're not physically with them.

There's also an ageing population in St Paul's gardens which would highly benefit of a change in environment that can be accessed right on their front door. The greenery and respite spots in the oasis would be a welcome change to the current space offering no senses stimulations.

The main aim of the project is to bring to St Paul's garden the same play opportunities and experiences for development as other less deprived areas in Bristol and attempt to close the gap of divisiveness a little bit through this oasis

# How does your project support development by delivering: (500 words maximum)

i. the provision, improvement, replacement, operation or maintenance of infrastructure:

Over the years, TALO has facilitated and delivered many community meetings and activities in St Paul's. From coffee mornings where women residents raised their concerns about issues in their neighbourhood to offering support during the pandemic and hearing first hand the vitality of outdoor spaces to residents' wellbeing especially as their housing situation was restricted and in most cases without a garden.

The space where the oasis would be located is known locally to residents as the 'rock park' due to its dusty and rocky surface. This area, along with the small park located next to it, have been a top topic of improvement voiced by the residents with a sense of belief that this patch of Bristol has been left behind and needs renovation. TALO was involved in a previous CIL bid headed by the Architecture Centre called the 'Green way'. Through our input, we lobbied for the Halston drive community room and outside space to be included in the renovations. The benches are widely used especially by parents after the school run. During the 1st CIL bid, it was clear to TALO that residents were receptive of the appealing aesthetics of the murals and ground lights etc...However, there was a yearning for more practical use especially for the large focal space that has always been used for football.

Through our consultations with the community, we also know that there is a smaller ageing group that would also benefit from a nearby park with more greenery. Whilst there has been a few concerns around football and potential noise level as something the design of the oasis would need to contain.

TALO has a history of successful project management and delivery; from events, trips to long-term projects. We are able to plan and see through projects working within a specified budget and a timeline. We also have access to the support of previous CIL grantees such as Docklands and the Architecture centre..

As a smaller organisation, there's the benefit of less bureaucracy involved in getting the project underway. Additionally, our offices are located right next to the potential oasis enabling the team to check on its progress easily.

In regards to the current surface, as well as its 'rocky' nature, it's also uneven and poses accessibility issues. One of the first milestones in the project would be to remedy this by rendering the surface flat.

St Paul's gardens bring together different cultures, backgrounds etc.. This oasis would seek to bring the residents together by making sure they're involved in every step of the way both in its design and delivery because in the past, residents have voiced to TALO not knowing about developments happening on their doorstep.

We will encourage people with protected characteristics to join especially from Black and Asian minorities ethnicities, elderly people, disabled people and women and girls because these groups are under-represented in consultation and decision making in St Pauls, we know this through past consultations we've supported.

We aim to seek elderly people's input so that it is a welcoming space that has a balance of play and respite across generations. We already work extensively with the Black and Asian minorities and will target our existing groups as a first point of contact.

We plan to seek advice from organisations and groups working with disabled people on how to make sure that the oasis is fully accessible and has facilities attractive to people experiencing both physical and mental disabilities. Finally, we will focus efforts towards women and girls as a group due to the current 'rock park' is used mainly by boys and young men playing football, we would ensure to include their input on how best to design it so that it is welcoming to girls and women.

Our hall Roof needs replacing, due to weathering due to age. Having been built in the 1960s it needs to be upgraded to modern standards. It is a flat roof, with roof lights, felting and concrete sections. The large hall space beneath is used almost every day including at weekends and is the one of two larger spaces in the building: the only larger spaces available locally. Replacing the roof will enable Faithspace to continue serving the locale by keeping its spaces available, the demand for which has been demonstrated since 2015. As we have built up the use and possibilities of the premises as a community centre , we have evidenced the need for not just one, but the two big spaces it offers and the smaller' flat 'area , which had originally been a caretaker's flat. This has meant that we have often had all three spaces in use at once and know the huge gap this would leave in local amenities if it were not there. It would enable the possibility of continuing as a meeting and gathering place, where community issues can be addressed, the sense of community which this creates and the possibilities that ensue for future benefits to the health, wellbeing and resilience of what is a highly deprived community.

Wellspring Settlement is a community anchor organisation working across Lawrence Hill and other areas of inner city and East Bristol. We work with all ages, ethnicities and communities, delivering services, community space and resources to support our vision of strong, dynamic communities where everyone has a good quality life. Our projects cover community engagement and development, family centre activities and support, social prescribing and other health-based projects and projects to support people's finances and employment to build economic opportunities and resilience. We are landlord to 15 organisations based on our sites.

#### Section 2c. Your Project:

#### i. Please describe the project you want to deliver (200 words maximum) (attach any plans, drawings etc as an appendix):

The old Swan pub building is a community asset in Morley Street, Barton Hill that Wellspring Settlement took into community ownership, with two clear aims. Firstly, to provide a safe space for children and young people to experience new activities that expand their aspirations, self-motivation, offering a place to socialise - a need compounded by health inequalities, including obesity, and increased anxiety. Secondly, the centre will provide a base for local people to access a wide range of local activities, including social and recreational, as a place that reduces isolation, and increases participation of the most excluded. We envision that the development of the Swan will also help create community cohesion, resilience, and a sense of local belonging, motivating people to partake in community led activities to meet local need; providing volunteering opportunities and pathways into local employment and training. The required funding would ensure the transitioning renovation of the premises is addressed, having also considered the lack of shared community facilities in Barton Hill and especially a lack of community space for young people.

This funding will also contribute to the renovation and modernisation of the Swan property, to offer much improved accessibility, especially for people with disabilities. The redevelopment work is underway to make the building weatherproof and structurally sound with monies contributed from Wellspring Settlement and the Nisbet Trust. The money from this application will fund the next phase which is the windows, doors and rendering. Planning permission was obtained on the 25th of October 2022. Wellspring Settlement is committed to ensuring this community asset is overseen by a sustainable funding regime, based on the needs, interests, and aspirations of the local community.

It addresses the demand that increases in population numbers due to additional development over the last ten years has placed on an already stressed overpopulated community by providing additional resources for young people and communities of all ages. Most of this housing in the direct catchment area of this project has been social housing and so has increased need for more supportive services as well as the need for new communities to meet with each other and the established communities in the area. Families in this area are also larger than the City average and so most are living in cramped and overcrowded, unsuitable conditions such as 8 person families in 2-bedroom high rise flats. The housing has also occupied many of the small brownfield sites scattered through the area, resulting in fewer places for casual congregation and adding to the feeling of being crammed into too little space which was exacerbated by Covid when the need for outside spaces was called for many times in conversations between people and with us. This development increases the spaces for that casual congregation and intermingling so craved for in this community.

Major developments in housing in the area plus the future Temple Quarter development will place more demands and increases on the population in an already overcrowded part of the city. It is likely that the next wave of new residents will be students, renters of new flats or homeowners of new housing which is unaffordable for residents of Barton Hill. The new developments are unlikely to benefit residents of this area who already struggle with high needs due to the covid and cost of living crisis. The development includes new sites for the University of Bristol, hotels and other organisational HQs and although Wellspring Settlement is working hard in partnership with these organisations, the demands on the infrastructure such as roads, school places, public services is likely to either reinforce a "them and us" feeling or overwhelm already insufficient provision in Barton Hill and surrounding areas.

iii. How will this project address the demands you've identified? What are the chief benefits that the project is designed to deliver?

We will provide increased community facilities and services which draw from across the new development area, offering opportunities for the existing community to meet new residents and develop strong interconnected mechanisms for getting to know each other and build common strengths and interests. We believe that redeveloping The Swan as a community and youth space will provide an excellent space to do this in. It will also be new and a mark of pride for the existing communities of Barton Hill.

The area has the highest proportion of young people in the City and consultation with them and their parents over the last 3 to 4 years has highlighted the need for youth provision as the priority for this area. All are saying this more post covid as this has increased mental health concerns for all, but particularly young people. We have appointed 2 part time youth development workers to work out in the community for 6 months with local young people, to help add depth to our understanding of the issues they are facing and to develop a young people's forum to work on the youth provision which will be delivered from the Swan in partnership with several providers.

The community space will be used by several partners to extend their work, particularly the Somali Resource Centre who are expanding their numbers and activities to meet increased demand. We will also ensure that intergenerational activities and activities to bring the communities together will happen during the daytime in the space. This will increase community cohesion.

The youth and community space aims to provide an inclusive environment for all.
The building's location is close to public transport (buses and trains at Lawrence Hill). There is cycle parking on site. There is no dedicated car parking immediately outside <i>and</i> there is unrestricted on-street parking.
The Settlement is well signed in the surrounding area. The youth and community space will be clearly signed within the Settlement site and the exterior of the building will clearly show its name and function.
The youth and community space will have level access from the pavement (corner of Morley St and Bright St with dropped curb) and from the courtyard at the rear which will in turn connect through to the main Settlement courtyard (with ramp access from Ducie Road).
Internally the two large spaces have a small change in level between them. A ramp will facilitate movement between these levels. To the rear there is a disabled toilet and four unisex toilets.

We have policies and procedures in place to manage the finances of the redevelopment and a sub group of the Board, with construction and other experience, overseeing the development, reporting monthly to the full Board.

The senior team have the appropriate qualifications including BSC Construction Management and Diploma in Safety and Health. We will project manage the development and engage contractors to do the work.

We are networking with local youth providers and Playful Bristol. We will work in partnership with the Somali Resource Centre to do further young people's development work and have a funding bid in for this. The Somali Resource Centre has been offered first use of the community facilities during the day as they require more space. The community facilities will develop through our community engagement team working with local residents. Our core purpose is to create community cohesion so Speedwell residents can have a good life. To do this we hold events from our small Centre such as retirement clubs, summer parties and dog shows. We're diverse; with 20 languages spoken. However, we're also deprived; Speedwell being within the 10-20% nationally deprived areas. We're lively, but also challenged & work together to support young and old residents. We want to build something Speedwell has always been missing, a central heart. So, in 2016 we set a long-term vision to create a community hub based around our current small Centre.

#### Section 2c. Your Project:

**i.** Please describe the project you want to deliver (200 words maximum) (attach any plans, drawings etc as an appendix): The proposal is a 97sqm extension to Meadowvale Community Centre. The extension will transform the centre it into a yearround venue with a capacity of 120 people. Summer events are well attended using the outside space but other times we're space limited, which affects our sustainability as we often cannot accommodate bookings (12 lost in 2019). Speedwell residents have been shaping our vision and said they want affordable sports activities for young people and pensioners.

We need the Centre to appeal to both young and old. We've made sure our extension is multi-use, suitable for indoor sports and includes a community café. We're working with our partners (Police, Safer Options team, CYN, Children's Centre, sovereign housing) to create a teen hub and Rotary and Age UK to support older people too. To kick-start things teen outreach has begun and we've launched a new retirement club holding exercise classes, quizzes and memory sessions.

To be sustainable we need an income and a café is key. There are no free, casual meeting spaces in Speedwell and we believe this is a factor in the isolation of older people. During refurbishment in 2018 we installed a catering kitchen ready for the café to open.

Meadowvale was identified as a priority project in the St George Community Network Plan. As our community is growing more people are getting engaged in setting our shared vision. Our new community hub will be an inviting meeting place for new residents, reducing social isolation, improving mental and physical well-being, and reducing disadvantage and inequality in our community. This will reduce the reliance on statutory services that are already stretched to the limit.

#### Working with our partners to create a heart for a growing community

The café and activity sessions in our community hub will provide a safe, comfy space to chat, be heard, get active and feel valued. The hub will also become a natural home for Police drop ins, councillor surgeries and Health Visitor appointments. The Children's Centre has also committed to use the space for parent groups as they regularly outgrow their space. This new community hub will bring legibility to the streets in Speedwell supporting new residents to settle in.

#### Activities for the young, designed by the young

To make sure that our trustees keep up with the needs of teenagers locally we are proposing to start a board of youth trustees who will join meetings to advise the CA on what is needed and the strategic direction for activities for young people. We already have a few young people supporting us to make sure the expanded centre provides activities teens are looking for. This simple idea will make sure local kids buy into the Centre and it is led by their peers.

#### Pulling opportunities into Speedwell

Over the past three years, we've pro-actively sought out the support of other organisations who we can partner with to bring opportunities to Speedwell. There are natural links with the nearby Children's Centre but we also explore many links with organisations to reduce inequality and give people the opportunities living in Bristol should bring. With our new Centre these will include:

- Food growing with Speedwell friends allotment project
- A community fridge for access to free fresh food diverted from landfill with FareShare
- Weekly food club
- Careers training, application support and mock interviews with professionals at Bristol Rotary
- Working with Age UK and various groups such as Sovereign Housing, Smiles Matter and the Care Forum on initiatives eg Picnic in the Park and community get togethers.
- Czech & Slovak Community and School Bristol CIC returning to the Centre with room to grow.
- Empire Boxing , wickets cricket, football organizations have already expressed interest in using the new hall.

Over the last 5 years the CA has reinvented itself. Residents believe and can see that their community is changing for the better in spite of recent challenges with anti-social behaviour and they have a powerful voice in steering these changes. We have a track-record for delivery having secured £80,000 from Cory Ibstock for new play equipment on the green space and raised £97,000 and project managed the refurbishment of the existing Centre building.

We are very fortunate to tap into the resources available from Bristol Rotary club and Chris Askew architects for planning, design and project management expertise. Despite our first builders going into liquidation, spiraling costs and the challenges of Covid which delayed the start of the build, we have persevered and overcome these challenges demonstrating our resilience and commitment. We have already raised over £300,000 for the new build. The new hall is near completion, and we just need a little more funding to get us over the finish line so that we can open again to our community and offer a wider and richer range of activities for Speedwell's diverse population.
