4. The application has been advertised in accordance with Section 51(3) of the Licensing Act 2003. The notice has been displayed at the premises and notices have been displayed at Council Offices situated at 100 Temple Street, Bristol and City Hall, College Green Bristol.

# **Recommendations:**

- 5. That the subcommittee:
- 6. (i) hold a hearing under section 52 of the Licensing Act 2003 to consider the application and any relevant representations; and
- 7. (ii) Having regard to the application and representations take such of the steps mentioned below, if any, as it considers appropriate for the promotion of the licensing objectives.

The steps are—

- (a) the modification of the conditions of the premises licence,
- (b) the exclusion of a licensable activity from the scope of the licence,
- (c) the removal of the designated premises supervisor from the licence,
- (d) the suspension of the licence for a period not exceeding three months, or
- (e) the revocation of the licence

Where the subcommittee takes a step mentioned in subsection (a) or (b), above, it may provide that the modification or exclusion is to have effect for only such period (not exceeding three months) as it may specify. In making its decision, as with the exercise of all licensing functions, the subcommittee must have regard to the guidance and policy included in the subcommittee's pack
