

#### **CCTV** Upgrade





## Background

- Bristol Operations Centre and Housing and Landlord Services project to upgrade CCTV offer
- H&LS element to upgrade CCTV cameras on housing land
- £655,000 investment over two financial years
- £327,000 in 2023/24 to support enabling works for upgrades to infrastructure and cameras
- 473 cameras and equipment across housing sites



## Background

- Number of CCTV cameras are obsolete, unsupported and at end of their life
- CCTV is on an analogue network instead of digital - Digital signal is more efficient and provides clearer images
- Priority sites identified by councillors, police and housing staff in conjunction with local residents



# Safer Streets Funding

- Home Office Initiative £75 million for the England and Wales in 2022 - 2024 (sum and period varies)
- Funding relates to crime prevention plans in areas affected by high levels of neighbourhood crime, such as burglary and robbery
- Police and Crime Commissioners (PCCs) with local authorities can submit bids for 'hotspot' areas – usually one bid per PCC area (there are 49 in England and Wales)
- PCCs shortlist and make final decision for award of funds
- £32,000 match funding was secured



#### Safer Streets

- Safer Streets funding used to upgrade the infrastructure and cameras at St Mathias House (St Jude's), Middleford, Millmead and Hayleigh House (Hartcliffe)
- St Mathias used as test site as complex and had no cameras
- Hartcliffe sites selected by police, community development, housing due to ASB concerns
- Infrastructure works complete and new cameras are in operation



### Progress to date

- Upgrade of CCTV recorders and data storage –
  45k
- Lansdowne Court and Ecclestone House
  - Works have commenced completion due August
    2023
- Commence upgrade works to blocks in priority band 1 in 23/24



## Challenges

- Coordination of CCTV infrastructure surveys with the Mechanical and Electrical (M&E) service who are already undertaking surveys in blocks
  - Coordination of surveys limits the impact on residents
- Surveys may uncover a range of issues that add delay to the project such as asbestos which needs removing
- Being able to complete all priority 1 sites in 23/24



#### Opportunities

- The project provides opportunity to enhance the CCTV offer
  - add additional cameras in blocks to increase surveillance
- The quality of images will be vastly improved and help with identification of perpetrators
- CCTV data stored securely



#### **Next Steps**

- Project commitment that blocks in priority band 1 will be upgraded in 23/24 - challenges permitting
- Those in priority bands 2 and 3 will be reviewed and budgets identified and approved for work
